2	OPEN FORUM No new issues received, all issues included on the Agenda.
3	POLICE REPORT There had been one incident in Kildale, where a lady from Kildale had been knocked down by a cycle who was taking part in the Coast to Coast event the lady in question was taken to hospital. The Parish Council had also received complaint about this race where an amount of litter had been left on the road side near the village hall, and about the riders on the road, and also about the number of cars park on the road side. The Cycles group don't have to inform the Parish Council of any cycle events which are going to be held in the parishes. It was felt at the meeting that the Village hall Committee to work more closely with the events organization and feedback concerns. There had also been two motor vehicles with a number of persons in them, going round the parish selling farm gates and the other one selling bed mattress

6	PLANNING APPLICATION GRANTED BY H.D.C 15/01060/MBN – Mr K. Harrison, Demblin, Ingleby Greenhow. Change of use of agricultural building to a dwelling house. Prior approval notification approved. The Councillors felt that there could be more of this type of application coming in, for areas out the N.Y.M.N.P.A. Cllr R. Kirk agreed to ask H.D.C planning for more guild lines for Parish Councils.

8 CLERKS REPORT ON ACTION FROM MEETINGS

8.1 Affordable Housing Survey

There is now a 2 Bedroom House at The Railway Siding Battersby Junction for rent.

It was agreed that another housing survey would be completed and Easby would like to be included in this.

8.2 Highway issues update

30mph Old Battersby

Cllr H. Moorhouse, gave an update, Speeding restriction is being drawn up and will be publicised in Old Battersby and the Darlington and Stockton Newspaper.

8.3 N.Y.C.C. - re-village and N.Y.M.N.P.A signs – This was in hand.

8.4 Footpath Ingleby Greenhow, Cllr M. Staples left the room.

Report on site meeting state of footpath surface re Stone Stoup (pig park) to Manor.

Cllr T. Sutcliffe. Cllr L. Smith, Cllr R. Wills, Parish Clerk and Mr M & Mr A. Staples land owners met with N.Y.M.N.P Head Ranger S. Bassindale to discuss the state of the path.

It was agreed that once the field had been cut, the vegetation on the path would be cut back by the N.Y.M.N.P.A, to see if that would help walkers been able to use the path safely. A site meeting had been arrange for Monday 2nd November at 11am, to look at this path again to see if further work is needed.

Cllr M. Staples re-entered the meeting.

8.5 Old Battersby, New notice board.

It was agreed for Cllr L. Smith and the Parish Clerk to look into the cost of a new one.

8.6 Ingleby Estate, Water pipes

Parish Clerk had contacted Northumbrian Water about the water on the road. They had met with Cllr T. Sutcliffe and the Parish Clerk, they had completed testing and informed the Council that it was not their pipe that was leaking, they felt it was a land drain. Richard Wardman offered to look into this as adjacent farmer. Ingleby Estate would be asked again for a copy of their map showing where the water pipes in the Parish are. It was reported that the situation was getting worse.

8.7 Sewage Work Ingleby Greenhow, Cover on plant.

A meeting had been arranged with Bruce Walton of Northumbrian Water to discuss the new cover over the sewage works.

8.8 Verge Cutting Programme

The Councillors all received a copy of Plant Life leaflet on verge management to read before the meeting.

Ann Press, felt that the grass verges are looking better having not been cut, with more wild flowers coming back.

	In the past the Council have done up to 4 cuts a year, there had not completed any this year. The Council had received complaints from Members of the Parish about the state of the grass verges and why had they not been cut.. The Councillors felt that there become a safety issues, with the long grass falling in to the road, for walker, cycles, horse riders and car drivers, not been able to see the edge of the road. It was agreed a full cut on corners, T Junction and round village signs and half wide on other areas, and another full cut to be completed in September. The contractor Rob Alderson would be given a map and details where to cut. Some farmers do cut their own grass verges. Marsh Lane overhanging vegetation was discussed following complaints, A. Press informed the Council that the land up to the road belong to the Woodland Trust and they would not allow cutting. It was agreed that at December or January meeting verge cutting would be discussed for 2016. N.Y.C.C/ payment for urban highway grass cutting, the Parish Council would received a payment of £161, for cutting the verges. 8.9 Summer Newsletter 8.10 Cllr R. Sutcliffe would attend this meeting and asked N.Y.M.N.P.A to look at Coleson Bank Old Battersby to Baysdale route.
9	COUNCILLORS REPORTS Coleson Bank Old Battersby to Baysdale Cllr L. Smith informed the meeting that a Mr Tate had walked up, Coleson Bank from Old Battersby to Baysdale. He felt that something needed to be done about the stated of this road. Mr Tate had contacted Judith Ratcliffe, BHS Access & Bridleways Officer Hambleton North, who attended this meeting to discuss the state of Coleson Bank Old Battersby to Baysdale. Judith Radcliffe felt that Motor Powered Vehicles are ruining this routes, also the forestry Commission that been using this route to take wood out. This route which is mainly used by horses rider and walkers is now unused to them. The Parish Council had reported this route to the N.Y.M.P.A. in the past, but it is the responsibly of the N.Y.C.C. to do any repairs and in the past they had informed the Council that there has not been any money to do any repairs. It was agreed that the Council would contact N.Y.M.N.P.A and N.Y.C.C. to see if they had this routes on their agenda for repairs or preferably to downgrade it to a bridleway

10	BATTERSBY JUNCTION COMMUNITY ASSOCIATION The Clerk informed the meeting that H.D.C had award them a grant of £19,065 for the play area. The Director were very pleased with this and are now waiting for the conformation on their application to Briffa for their grant.
