8	PARISH COUNCILLOR'S REPORT 1. Queens Platinum Jubilee 2022 The Parish Council RESOLVED a budget of up to £500 to purchase a gift for Children in the parish and any child attending Ingleby Greenhow school. (Mug, Egg Cup, Crown) 2. Area near to Ingleby Greenhow post box It was RESOLVED for Cllr T Sutcliffe to investigate a cherry tree or rowan to be planted in this area to mark the Queen Platinum Jubilee and report back to the Council. Councillor Martin also agreed to research another type of cherry tree. 3. Overgrown Hedge Greenhow Cllr L Smith has contacted the owner at Howe Hill Farm, and they would look at cutting the hedge back.. There are also two other areas which need to be looked at including

	<p>the field opposite the hedge on the Greenhow Road. Cllr L Smith agreed to contact the owners.</p> <p>4. Village Boundary Stones</p> <p>Cllr L Smith has contacted the NYMNPA to see if they had any stone to replace the one opposite the cricket's field. Unfortunately, they do not have any. Cllr T Sutcliffe agreed to investigate finding some stone. The boundary Stone on the Easby Road needs to be re-erection.</p> <p>5. Gullies Clearing</p> <p>NYCC H Moorhouse informed the meeting she had been advised by NYCC contractors that the gullies in Ingleby Greenhow were last cleaned on the 17th of April 2021. When the annual clean is completed the system marks these gullies as blue, this prevents any duplicated cleaning being carried out as they cannot be cleaned whilst showing as blue on the system. The system will mark these as red after a full 12 months which will then allow the gullies to be booked for cleaning again, in this case this will not happen until after the 17th of April.</p> <p>Cllr T Sutcliffe informed the meeting that Highways have cleaned the gullies from Old Battersby to Battersby Junction but did miss one near to the Old Hall Battersby. Also, north of Ingleby Greenhow and Old Battersby there are gullies which have not worked over the last three months there are also other gullies which have not work for some time. RESOLVED to write to NYCC Highways regarding the blocked gullies.</p> <p>Cllr H Moorhouse reported again to the meeting that the gullies are on annual clean.</p> <p>6 Car Park opposite St Andrew Church Ingleby Greenhow</p> <p>Cllr T Sutcliffe reported back on a query he had recently fielded regarding the status and usage of the car park opposite the Church. The Parish Council confirmed that the car park is a Parish Council asset publicly funded with support from NYMNP and constructed by NYCC, and more recently resurfaced by the PC, and that it is a public car park open for use by all. The Parish Clerk shared a letter received from NYCC Highways in 2001 confirming the status of the highway verge in that area. The issue of dog fouling and litter had also similarly been raised in the recent query. The PC considered further dog/litter waste bins were not required in the area”</p> <p>7 Verge Cutting</p> <p>The Parish Clerk informed the meeting that the first cut would take place first week in June. There would be an increase of £40 on this cut.</p>

	<p>8 Gilder Toft Ingleby Greenhow</p> <p>Cllr T Sutcliffe asked at February meeting that the Parish Clerk report water standing opposite the entrance to Gilder Toft water regularly ponds well across the road whenever there is heavy rain.. Cllr T Sutcliffe reported that this has been a long-standing issue as the gully is not at the bottom of the dip in the road. He felt that more comprehensive attention or the gully lowering or relocating was required and it was RESOLVED to agree to write to NYCC Highways requesting action to address the issue.</p> <p>Cllr H Moorhouse informed the meeting that she had seen this but felt it was not causing any safety issues and no member of the parish has reported any issues.</p> <p>9 Ingleby Bank</p> <p>Residents near to Ingleby Bank have requested the route go onto the gritting route and to have a sign at the top and bottom of the bank warning drivers that in winter this route is dangerous This route is also used for children living in Chopgate who attend Ingleby Greenhow School. The verges are in a bad state as there is water coming from the forestry. NYCC to be asked to investigate this.</p> <p>Cllr H Moorhouse reported to the meeting that she has asked Highway for signs on the bank and was informed that they are not putting new signs up. Cllr H Moorhouse has asked for this route be put onto the gritting route.</p> <p>Cllr T Sutcliffe asked for the PC to write to NYCC Highway to investigate the water which is coming across the road from Forestry England land where the ditches/gutters have not been properly maintained and now require reinstating.</p> <p>It was RESOLVED to agree to write both to NYCC Highways and Forestry England requesting action to address the issues.</p>
9	<p>NEW ISSUES</p> <p>1. Water on Easby Bank near to Easby Chapel</p> <p>HDC Cllr R Hudson asked Cllr H Moorhouse could Highway address this as water has been running down the bank for a few months now and the road has been dug up by Northumbrian Water four times and water is still running down the bank. Cllr H Moorhouse agreed to investigate this.</p> <p>2. Parish Council Website</p> <p>The Parish Clerk has received a request from a resident to make some changes on the website on local Business. Cllr T Sutcliffe stated that on the opening page his name is down as Chairman the clerk will change this.</p>

10	<p>NYCC COUNCILLOR REPORT</p> <p>1. Bank Foot Road On entering Bank Foot Road on the right, the road has been marked and Highways have put in an order to have the edge of the verge repaired. There is still a problem with the edge of the road near to the footpath sign going to the Manor with standing water. Highways say that the water is coming of the field and is the responsibility of the farmer at Bank Foot. He has reported to Cllr H Moorhouse a drain near to the house, which is blocked. Highways to be asked to have a look.</p> <p>2. Footpath Bonnie Hill The work has now been completed on the bridge on the footpath.</p> <p>3. Water Beck to Clay Bank Road. Work on this section will take place in this financial year.</p> <p>4. Surface Dressing of road in the Parish.
