| 1 | <p>PRESENT Cllr T Sutcliffe Chairman, Cllr L Smith, Cllr M Staples, M B Bowes Parish Clerk. The chairman welcomed NYCC Cllr H Moorhouse, HDC Cllr R Kirk, HDC Cllr R Hudson, C & R George, C Cutler from Easby, C Bianco, S Pearson, D Crawford from Ingleby Greenhow, P Finn from Old Battersby.</p> |

| 8.1 | <p>BROADBAND PROVISION – OPENREACH The Chairman provided an update on the provision of superfast broadband to Ingleby Greenhow:</p> <ul style="list-style-type: none"> • Work had commenced in the Autumn with the provision of the green connection box at Village Farm, Ingleby Greenhow. • Work on the provision of the connecting fibre cable had started on 15th December with the erection of 20 poles from Easby toward Ingleby Greenhow. This work had currently stopped north of Station Farm entrance. • No consultation or prior information had been received by the Parish Council, the NYMNPA or adjacent landowners. • Following enquires with BT Openreach and NYNET (the funder of the project) a site meeting was arranged by Openreach with NYMNPA, also with the Parish Council, adjacent land owners, NYCC Cllr H Moorhouse and NYNET on the 5th January. • No plans of the route were available at the meeting and it was unclear how the lines would reach the village. There had been a failure to consult the NYMNPA. <p>The main areas of discussion that took place at the Parish Council meeting were.</p> <ol style="list-style-type: none"> 1. Firstly there was unanimous support for the village to be connected to a better broadband service. 2. There was surprise that the line would link to the village via poles and overhead lines and not be undergrounded as was the case from Gt Ayton to Easby. The poles were considered by some to be unsightly and damaging to the landscape of the area and trees in the hedgerows. The issue of road safety and sustainability and possible damage to the lines were also raised. 3. Others, however, just wished to see the connection take place as quickly as possible by whatever means. <p>Following discussion the Chairman agreed to seek further clarification and information from Openreach and NYNET on the project plan, implementation methodology and time-scale.</p> |

| 5.1 | <p>16/02395/FUL Mr Blackett, Station Farm, Ingleby Greenhow Construction of an agricultural building The Parish Council resolved no objection, the only comment was regarding safe guarding the footpath on the original application. This application is an extension to Ref 16/01856/FUL which had been approved. Footpath Officer to be contacted again.</p> |
| 5.2 | <p>ATKINSON WOOD FARM, EASBY A Muir NYMNP Planning Enforcement Officer, informed the Parish Clerk that Ingleby Estate did know that some work was to be done, but did not know the full scale of the project. NYMNP had sent two letters to Mr Jewdell the occupier which he had not replied to. A further letter would be sent and if he did not acknowledge this letter the Enforcement Planning Team would make a visit to discuss the unauthorised building work.</p> |

| 7.1 | <p>Highway issues Road Closure The Parish Council had received an email on the 16th December from Area 2 informing them that 11252 from Ingleby Greenhow to Battersby and Ingleby Greenhow to Gt Broughton road would be temporarily closed for a period of 2 days between 22nd and 23rd December for potholes repairs. Highway had filled in some potholes on the Ingleby Greenhow to Gt Broughton road. No work had been done on the Ingleby Greenhow to Battersby road.</p> |
| 7.2 | <p>Footpaths Atkinson Wood Farm Simon Bassindale NYMNP had been asked for an update for the section in the NYMNP. No update received. Cllr T Hill had emailed that the issue of the footpath outside the NP had been raised by members of the public. No formal application had been submitted to divert the path and as yet no signage to indicate the new route. Parish Clerk to contact the NYCC Footpath Officer and Ingleby Estate who are the landowners to seek to rectify the situation and formalise the diversion</p> |
| 7.3 | <p>Mr Blackett Field immediately North of the level crossing, The issue of the state of the footpath and stile had been raised by a member of the public. The stile has fallen apart and the area is muddy making it difficult to get across. Cllr T Sutcliffe agreed to contact Mr Clark to see if this could be improved by his tenant.</p> |
