The New Committee on the Village Show making this a success Battersby Junction Residents taking forward action on the access road. Battersby Station Group on their work on and around the Station. Battersby Junction Community Association work on the Play Area. Applying for Grants and purchasing equipment. Old Battersby Water Users Group on the success with their work getting safer water supply up and running.</p> <p>Parish Council Issues The main issue was how Broadband was brought into Ingleby Greenhow at the end of 2016. The Parish Council had not been consulted on this, and poles were put up on the Easby to Ingleby Greenhow road. A number of Parish Residents complained about the unsightly poles. The Parish Council spent a considerable amounts of effort trying to have the lines under ground. Unfortunately the Company were allowed to put the poles up with out planning permission. From Ingleby Station House to the entrance of Ingleby Greenhow the lines are underground, as this is within the NYMNPA. In the next round of superfast broadband we will see if we are able to apply for Battersby.</p> <p>Highways Issues Re-surfacing of Lambs Lane this year. Footpath resurfacing was completed in Ingleby Greenhow. Coleson Bank Closure is still ongoing, but illegally used by some 4x4 and motorcycles. Bank Foot to Bloworth Crossing road is in a dangerous condition and NYCC have</p>

been asked to undertake a Health and Safety Assessment as to whether it is still suitable for vehicles to use.

Fly Tipping probable in the Parish remains a problem.
